**In the matter of the *Commissions of Inquiry Act 1950*****Commissions of Inquiry Order (No.4) 2015****Barrett Adolescent Centre Commission of Inquiry****AFFIDAVIT**

I, Michael Walsh, c/- Crown Law, state on oath:

1. I am the Director-General of Queensland Health and have held this position since 6 July 2015.

**Requirement to Produce Documents**

2. On or about 14<sup>th</sup> of September 2015, Ms Annette McMullan, Chief Legal Counsel, Queensland Health informed me and I verily believe that Queensland Health had received a Requirement to Produce Document addressed to me dated 14 September 2015 (**Requirement**) from the Commission of Inquiry (COI) and briefed me about the team of people who were already working on the collation of relevant information.
3. I was confident that Ms McMullan would ensure that the people with the appropriate skills and knowledge to address compliance with the Requirement would be working on achieving that outcome.
4. Ms McMullan informed me and I verily believe that the Department Co-ordination Team (the COI Team) comprises six (6) persons (five (5) on a full time basis), including three (3) lawyers, two (2) persons experienced in mental health related matters and one (1) paralegal.
5. I delegated the day-to-day oversight of receiving updates on my behalf regarding compliance with the Requirement to Ms Louise Burke who is a Senior

Director of the Office of Director-General at Queensland Health (Department of Health).

6. Ms Burke is effectively the link between my office and the COI Team within the Department of Health. I am aware that Ms Burke was attending fortnightly meetings with Ms McMullan and other key people about the COI and the Requirement, with the purpose of bringing to my attention any challenges that arose in relation to the conduct of the Inquiry.
7. I am informed by Ms Burke and verily believe that it has been necessary for requests for extensions to be made on my behalf, largely related to the challenges encountered in restoring records from an obsolete email system.

**Conduct of Enquiry in relation to the Notice/s**

8. I am informed by Mr Colin McCrerrick, Chief Technology Officer, Queensland Health and I verily believe that the Department has been working on restoring archived email documents since February 2015. At that time, I understand that an election commitment had been announced to conduct a COI into the closure of the Barrett Adolescent Centre.
9. I was not the Director-General at that time, however shortly after I commenced in the Director-General role, I was made aware that the Department had commenced work in preparation for the COI, including the continuation of restoration of emails. I was supportive that such work continue. I considered the preparation for the anticipated COI to be important.
10. I am informed by Mr McCrerrick and I verily believe that the email restoration process started with the email accounts of West Moreton Hospital and Health Service as at February 2015, as they were the Health Service that operated the Barrett Adolescent Centre. In addition, I am informed by Ms McMullan and I

verily believe that the restorations commenced for this Health Service not only in preparation for a potential COI, but because of a current investigation that was being undertaken by the Office of the State Coroner.

11. It is important to note that although the COI Team had commenced and was using its best endeavours to source and collate information that appeared to be relevant to the Terms of Reference, the first Requirement Notice was much broader and more extensive than the Department and its legal advisors had anticipated, requiring records dating back, some 30 years, to be produced.
12. I am informed by Ms McMullan and I verily believe that the COI Team responded accordingly and undertook best endeavours to continue to seek records in compliance with the COI's Requirements.
13. I am informed by Ms McMullan and I verily believe that over the time since receipt of the Requirement, the Department of Health has progressively received more detail (such as the date considered by the COI to be the patient "transition date") and has gained a better understanding of what was needed to comply with the Notice. The Department has therefore become more informed and now has a more fulsome appreciation as to the enormity of the task of complying with the Requirement.
14. As Director-General, I am informed by Mr McCririck and I verily believe that the Department of Health has two major limitations (aside from email issues) that have impacted its compliance with the Notice. Those limitations are that:
  - (a) the Department does not have any central or uniform electronic document management system; and
  - (b) the Department does not have a tool sophisticated enough to comply with the COI's Document Management Protocol.

15. Accordingly, I am informed by Ms McMullan and I verily believe that the Department is completely reliant on the use of a litigation support database sourced by the State's legal representatives, Crown Law, to facilitate the COI's requirements and to be compliant with the Protocol.
16. Within the Department of Health, I am informed by Mr McCririck and I verily believe that the following staff have been working on and co-ordinating the restoration of email accounts as part of its compliance with the Requirements issued by the Commission:
- (a) Russell Hart (A/Senior Director, Service Management, HSIA):
    - (i) Co-ordination;
    - (ii) procurement;
  - (b) Bobi Damevski (Manager Exchange and Messaging, Service Management, HSIA):
    - (i) Co-ordination;
    - (ii) Exchange Restores;
  - (c) Mark Schmiede (Team Leader Exchange and Messaging, Service Management, HSIA):
    - (i) Exchange Restores;
  - (d) Glen Turvey (Manager Brisbane City Service Delivery Team, HSIA):
    - (i) Co-ordination.
17. The following people have been working on GroupWise Restores:
- (a) Pallavi Mohan (Operations Specialist, Service Management, HSIA );



- (b) Siamak Mostashary (Messaging Administrator, Service Management, HSIA);
- (c) Andrew Simons (Principal Technology Officer – Servers, HSIA);

- (m) Glen Turvey (Manager Brisbane City Service Delivery Team, HSIA);

- (o) Hogarth Forrester (Server Administrator, Brisbane City Service Delivery, HSIA).

18. I am informed by McCrerrick and I verily believe that the above-mentioned staff have been involved in some level or capacity since February 2015 and in that respect approximately:
- (a) three quarters would have spent up to a quarter of their day restoring email accounts for the COI;
  - (b) the other quarter would have spent half to three quarters of their time restoring email accounts for the COI.
19. I am informed by McCrerrick and I verily believe that to date, 14 terabytes of email data have been restored and processed for delivery to Crown Law. This data has not been processed to identify those emails that are relevant to the COI's Terms of Reference, nor to identify documents that may be privileged. The documents are in a '.PST' format.
20. Queensland Health uses a statewide email system (with a "@health.qld.gov.au" address), which is managed at Department level. As such, I am informed by McCrerrick and I verily believe that the Department is still facilitating the production of emails with those addresses that have already been requested, including for all Hospital and Health Services.
21. I am informed by Ms McMullan and I verily believe that access to the Hospital and Health Service emails has already been provided to West Moreton and Metro South Hospital and Health Services. The Department of Health will make arrangements for other Hospital and Health Services who are separately represented for this COI to have access also as any need arises.

**Provision of documents to Crown Law**

22. I am informed by Ms McMullan and I verily believe that the COI Team has supplied Crown Law with documents and/or information which is contained in Exhibit A.
23. I am informed by Ms McMullan and I verily believe that as at approximately 30 October 2015, the COI Team believed that it had provided Crown Law with all material comprising network directory documents, scanned original hard copy documents and external hard drive documents that had been sourced across the Department as at that time. This excluded emails. However, as time has progressed, further requests for information and documents has been forthcoming.
24. I am informed by Ms McMullan and I verily believe that the review of the hard copy material was extremely time intensive for the COI Team and the scanning alone of the hard copy material was a particularly time intensive exercise, necessitating the employment of another short term administrative team member for approximately three weeks.
25. The material that was scanned included documents contained within 19 archival boxes of payroll records that had been reviewed by the COI Team.
26. I am informed by Mr McCrick and I verily believe that at present, there are 14 terabytes of restored email accounts that are in a format ready to provide to Crown Law. Although this data is currently available, the present task that the Department has been requested to undertake by the Commission relates to the following:

- (a) consideration as to delivery times for the email accounts of highest priority to the Commission as identified by its letter of 17 November 2015; and
- (b) consideration as to delivery times for the remainder of the email accounts that have been identified for restoring.

27. I am informed by Mr McCrerrick and I verily believe that that the restored emails are in a format known as ".PST" files that are readable through programs such as Microsoft Outlook.

#### **Email restoration and processing**

28. I am informed by my information technology staff and I verily believe that, to illustrate the magnitude of the amount of data the Department is sorting, one terabyte is equivalent to approximately 4.5 million books consisting of 200 pages each.

29. I am informed by Mr McCrerrick and I verily believe that there are approximately 272 email accounts, comprising both individual and correspondence accounts, that the Department is responsible for restoring.

30. I am informed by Mr McCrerrick and I verily believe that the email system for Queensland Health dates back to approximately 2007. The systems used for emails since 2007 are known as Groupwise (2007 – approximately 2014) and Microsoft Outlook (approximately 2014 onwards).

31. I am informed by Mr McCrerrick and I verily believe that to restore emails from the Groupwise system, the Department of Health is required to rely upon older and obsolete technology to convert tape based archive material to a readable .PST format. This archive system was only ever envisaged as a disaster recovery solution and not a document retrieval and search system.

32. I am informed by Mr McCririck and I verily believe that the process for retrieving this material involves:
- (a) identifying, for an individual, where the individual was located for each relevant time period in order to identify the relevant post boxes;
  - (b) locating the tape for the relevant post box for the relevant time period – the tapes are organised by quarter, with several tapes for each quarter;
  - (c) inserting the tape into an old machine – one which is capable of processing the data;
  - (d) converting this data into a recognisable format (.PST file), which involves a number of stages, starting with putting the material on a machine that is able to retrieve it from the tapes, and then several other stages which prepares the material to be readable in Microsoft Outlook.
33. I am informed by information technology staff and I verily believe that each tape contains approximately 500 gigabytes of storage. My understanding is that each three (3) month segment of a mailbox takes approximately five (5) days to process from its archived state to a '.PST' format, being a format able to be read in Microsoft Outlook. Eight (8) x three (3) monthly segments can be restored at any one time.
34. I am informed by the information technology staff and I verily believe that the Department is approximately 40 percent through what we estimate will be needed to comply with the Notice. The information technology staff have estimated that there is approximately 20 terabytes of data still to be restored.
35. I am informed by Mr McCririck and I verily believe that the process is time consuming because all emails in the relevant post box have to be restored, in order to restore just one (1) account.

36. I am informed by Ms McMullan and I verily believe that Exhibit B to this affidavit is a copy of a Spreadsheet that provides details of approximately 272 email accounts that have been identified for restoration, as well as details about the priority given to certain identified email accounts.
37. I am informed by Mr McCrick and I verily believe that the information stored in the archives of the Microsoft Outlook system, which commenced on a rollout basis from mid-2013 up to approximately March 2014, is the easier process for restoration. This is because it uses more current technology and does not require retrieval of information that is stored on tape.
38. I am informed by Mr McCrick and I verily believe that of the 272 emails marked for restoration, the restores from the Microsoft Outlook system can therefore be processed more quickly. For that reason, the Microsoft Outlook data has already been restored for email accounts, where those accounts had a Microsoft Outlook component.

#### **Priority emails**

39. I am informed by McCrick and I verily believe that Exhibit C is a Spreadsheet containing information which relates to the email accounts identified in correspondence from the Commission on 17 November 2015 which are the Commission's highest priority, and the volume and delivery times associated with the restoration of those accounts.
40. I am informed by my information technology staff and I verily believe that, as outlined in Exhibit C, ten (10) accounts which are contained in the Priority list from the Commission have already been restored and are ready for provision on hard drive to Crown Law.

**Commitment to compliance**

41. I have advised my staff that all reasonable efforts are to be made on behalf of the Department in its compliance with the Requirement Notice. Further, I believe that for the remaining email restorations, my information technology staff are using every resource currently available to meet compliance requirements.
42. I am informed by my information technology staff and I verily believe that the two machines used to restore and convert the email data have been running almost 24 hours a day, 7 days a week, since February 2015.
43. I am informed by Mr McCrick and I verily believe that if necessary, the Department may be able to procure additional machines. However, that process could take considerable time as the machines would need to be located, purchased and then installed and configured by suitably skilled staff.
44. Additionally, I am informed by Mr McCrick and I verily believe that the Department is experiencing limitations in its human resourcing of this task because special skills are required for the older technology and because Groupwise as I understand was not a widely used email system.
45. I am informed by both Mr McCrick and Ms McMullan and I verily believe that many Departmental staff have been working overtime and well outside standard work hours. I am concerned about the level of stress that this is placing on individuals for whom I am responsible.
46. I am informed by Mr McCrick and I verily believe that leave, of any type, of the staff working on the email restoration and conversion process will ultimately negatively impact on the Department's ability to produce the data.

47. I am informed by Mr McCrerrick and I verily believe that there are a few ways that the process may be able to be expedited further. The Department may be able to source additional skilled people who can assist with processing the data once the tape machines are finished with the data. Sourcing additional machines may be possible but procuring them, transporting, configuring and installing them will take time.
48. Given the discussed limitations, and the fact that there are a limited number of tape reading machines and skilled people who are able to convert the data from its archived format to one able to be read in Microsoft Outlook, I am informed by Mc McCrerrick and I verily believe that a best estimate for full compliance with the Notice, based on Exhibit C, will result in approximately 20 terabytes of additional data and is anticipated to take approximately 6.5 months from today.

All the facts sworn to in this affidavit are true to my knowledge and belief except as stated otherwise.

\*\*It should be noted that whilst the removal of the HHS accounts from the list will reduce the volume and costs associated with Crown Law processing that material, any remaining unrestored HHS data will still be responsibility of the Department of Health for de-archiving, before provision to the HHSs for processing/production. Accordingly, the reduction of 48 days in this line from 195 down to 147 days is based on the assumption that the Department is not required to restore any further HHS accounts.
