#### **BUDGET & FUNDING**

# 6.1 MHCWP Capital Budget -

- The original capital budget was \$148.351M and is now \$130.351M.
- \$4M has been removed in 2012-13 from the Townsville SMHRU as the project has been deferred until 2013-14.
- \$14M has been removed as a result of the cancellation of the Redlands Adolescent Extended Treatment Unit and used for other QH projects.
- To date, budget overruns have occurred on the SMHRU and acute unit at Caboolture (approximately \$2M), the high secure unit at TPCMH (approximately \$300,000) and the Logan acute unit (currently \$1.4m).
- Final capital costs provided by HIO for 23 bed secure mental health rehabilitation unit and 20 bed acute unit at Caboolture is forecast to be \$24,235,562 from Project Services, still to be negotiated down by HIO.
- An extra \$80-90K is required to fund the re-wiring of patient areas at Redcliffe/Caboolture acute unit
- Any overall programme savings will be directed to make up the shortfall in the Townsville SMHRU.
- It is forecast the overall capital program will be delivered within budget. Tenders are coming in below the estimated budgets.

# 7 RISKS

#### 7.1 Current risks noted include:

- Gailes CCU
  - Loss of income from the purchase of land to enable access to the Goodna site. Resale of this land will be at a loss and may not be directed back to the project.
  - Budget blow out
  - Ipswich Council may decline the application for Gailes if in breach of the Sustainable Planning Act.
- Rockhampton concept brief and approval required before commencement of project. .
