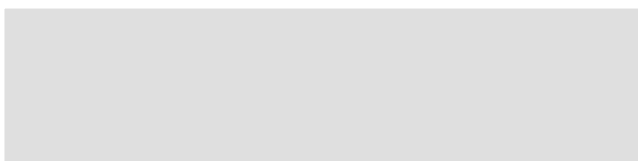
Dear Minister
