# Role and Function of the Organisation:

#### The Division of Mental Health

West Moreton Health Service District Darling Downs Health Service District

(Previously known as: Darling Downs - West Moreton Health Service District)

Introduction and Context

Queensland Health, the Darling Downs West Moreton Health Service District and thus the Darling Downs West Moreton Division of Mental Health are undergoing change. In this, reforms within the Queensland Health system respond to its legislative commitments arising from the Council of Australian Government's (COAG) Inter-governmental Agreement (20 April 2010) and COAG Heads of Agreement on National Health Reform (13 Feb 2011). The future establishment of Local Health and Hospitals Networks in this state aims to devolve operational management for public hospitals to the local level (Health and Hospitals Network Bill, 2011. Explanatory Notes <a href="http://www.health.qld.gov.au/health-reform/docs/HHN-bill-exp.pdf">http://www.health.qld.gov.au/health-reform/docs/HHN-bill-exp.pdf</a>). Within the Darling Downs - West Moreton Health Service District this has meant that on 1 July 2011 the Darling Downs - West Moreton Health Service District will separate to become two distinct entities: the West Moreton Health Service District and the Darling Downs Health Service District. During the transition to the two Districts as new governance structures are being developed, the Division of Mental Health will continue to function as a single entity under the leadership of the Executive Director of Mental Health reporting to the Chief Executive Office West Moreton HSD and the Acting Chief Executive Officer Darling Downs HSD.

Previously the Darling Downs – West Moreton Health Service District gazetted on 1 November 2008, was intended to reduce the number of Health Service Districts across Queensland from 20 to 15. The Area Health Services were abolished and new District Chief Executive Officers were appointed. At this time the former West Moreton South Burnett Health Service District (WMSBHSD) and the Toowoomba and Darling Downs Health Service District (TDDHSD) were amalgamated to form the new Darling Downs – West Moreton Health Service District (DD-WMHD). The current changes return many of the services to this earlier geographic configuration with some changes. Most notably, South Burnett services will be within the Darling Downs HSD (reflecting a historic link) and Gatton will be within West Moreton. In all, these changes are intended to benefit consumers of health services and as such, service to them should transition smoothly. Importantly, in this process efforts have been directed towards aligning structures, processes and practices wherever appropriate. Its legacy will be the establishment of common ground between the two HSDs that will be enhance in enduring relationships and opportunities to work together on benchmarking and the evolution of knowledge.

The following will describe the DD-WMHSD to assist the reader in gaining an impression of the service and its area reflecting its continued governance as a single structure during this transition.

# Darling Downs West Moreton Health Service District

The DD-WMHSD covers approximately 95,000 km2 to the west of Brisbane its eastern boundary, extending from the New South Wales border in the south to Wandoan in the north and Glenmorgan in the west. To the west (now the DDHSD) this incorporates the Regional Council areas of Toowoomba, Goondiwindi, South Burnett, Southern Downs Western Downs and the community of Taroom and the Cherbourg Aboriginal Shire Council and to the east (now WMHSD) incorporates the Regional Council areas of Lockyer, part of Somerset (Esk) and Scenic Rim (Boonah), Ipswich City Council and part of Brisbane City Council (Karana Downs and Lake Manchester) and includes the management of The Park - Centre for Mental Health which lies east of the Ipswich City Coucil border. The DD-WMHSD services a population of around 480,000 people who are demographically diverse living in metropolitan, large rural town and small rural community settings. The DDWM HSD employs approximately 5,700 full time equivalent staff with an annual operating budget of \$693m.

#### Division of Mental Health

The Mental Health Service provides comprehensive mental health services across the lifespan using multidisciplinary interventions. Its target is focussed on people experiencing mental illness and mental disorders characterised by clinically significant disturbances of thought, mood, perception or memory, for whom other services are either unavailable, clinically inappropriate, or require support from specialist mental health services to respond to their clients' needs. Reflecting the range of services along the health care continuum, services are provided in varied settings such as:

- community outreach
- acute inpatient
- extended inpatient
- secure inpatient
- forensic (including Prison in-reach)
- older persons (inpatient and community)
- child and youth
- evolve (children involved with Child Safety)
- education
- research

The Division of Mental Health employs 1320 full time equivalent staff and is allocated a budget of \$155 million and provides approximately 40% of the State's mental health services, making it the largest

integrated service in the State. Facilities within the Division are arranged to effectively meet the needs across the treatment spectrum such as Acute Services and Tertiary Residential Treatment (taking clients from other Districts and across the state as well as those from this District). Thus there are two large residential campuses (The Park - Centre for Mental Health at Wacol near Ipswich and Baillie Henderson Hospital in Toowoomba), Community Based Clinics throughout the District and Acute Inpatient Units (Adult and Older Persons) at Ipswich and Toowoomba Hospitals.

Considerable upgrading and development of the Division's facilites is in planning and underway. This includes redevelopment of High Secure Treatment Unit (9 bed) and Barrett Adolsecent Unit (relocation to Redlands is currently delayed on environmental grounds) at The Park, the Adolescent Inpatient Unit at Toowoomba Hospital and a Community Care Unit (delayed on environmental grounds) at Goodna. The current Federal Budget has indicated funding for a Community Care Unit at Toowoomba and relocation of psychogeriatric beds from Baillie Henderson Hospital to Mt Lofty Nursing Home. The impact of these developments is the downsizing of Baillie Henderson Hospital and the redevelopment of the Park as primarily a forensic treatment facility as Community Care Units in the South East come into being to provide Extended Rehabilitation.

#### Please Note:

During the process of amalgamation, all facilites have become known as a part of the Division of Mental Health whereas originally this title was used by Toowoomba & Darling Downs. With no disrespect intended to staff of these services, for clarity, the Division of Mental Health will refer to the whole Division across the District and Toowoomba & Darling Downs will refer to that sector.

#### **Facilities within the Division of Mental Health are:**

- Toowoomba Mental Health Service (Toowoomba & Darling Downs)
- Extended Inpatient Service, Baillie Henderson Hospital (Toowoomba & Darling Downs)

#### **Corporate and Support Services:**

In addition, Corporate and Support Services function externally to the Division and support the entire HSD. These are located at Ipswich and Toowoomba Hospitals which include:

- Corporate Services
- People and Culture

A brief description of the roles and functions of each Division of Mental Health facility follows.

#### **Toowoomba and Darling Downs**

The service is comprised of four clinical business units - Acute and Community (Toowoomba Hospital), Extended Inpatient Service (Baillie Henderson Hospital), and two rural services based at Dalby (Western Downs Division of Mental Health) and Warwick (Southern Downs Division of Mental Health).

1. The Acute and Community Mental Health Service a service linking inpatient services located at the Toowoomba Hospital with community services for children and young people, adults and older persons. Services offered include Triage and Acute Care, Adult Case Management, Acute Mental Health Inpatient Unit (comprising 51 beds), Older Persons Mental Health Service, and a Child and Youth Mental Health Service, and a Consultation Liaison Service which supports general health treatment at Toowoomba Hospital. In addition, specialist psychiatric consultancy services are provided to South West

Queensland and to South Burnett.

- **2.** The Extended Inpatient Services (204 beds at Baillie Henderson Hospital) provides services for consumers from the catchment areas of Toowoomba, Darling Downs, South West, Fraser Coast, Wide Bay and Central Queensland. These services are provided in five specialised programme areas:
  - Acquired Brain Injury,
  - Extended Treatment and Rehabilitation,
  - Medium Secure, Dual Disability and Older Persons.
  - Vocational and rehabilitation services are provided through the Living Skills Service for clients of the service.
- **3. Southern Downs Mental Health Service** is comprised of an Acute Care Team, a Case Management Team (which includes ATODS and Indigenous Mental Health), Older Person Team and Child and Youth Team. The service is accessible 24 hours/ 7days per week. Multi-disciplinary clinical staff are based at Warwick, Stanthorpe, Millmerran, Inglewood and Goondiwindi. The clinical teams report through Team Leaders to the Manager Southern. A Visiting Medical Officer Psychiatrist provides clinics to the Southern Downs both in person and by video conferencing
- **4. Western Downs Mental Health Service** provides services from Dalby and Chinchilla and provides outreach services to the surrounding areas. The service are available to adults and children and provides assessment and treatment by a multidisciplinary team, information and educations, case management, therapeutic interventions, referral to other services, consultation and liaison with other service providers and case conferencing.

**5. South Burnett Community Mental Health Service** provides community/ ambulatory services to Kingaroy, Wondai, Nanango Community health facilities and to the surrounding communities of the South Burnett catchment area (Blackbutt/Benarkin, Yarraman and Upper Yarraman, Murgon, Proston, Goomeri and Kilkivan). Two multidisciplinary teams provide Adult, Older Persons and Child and Youth community mental health services incorporating a shared model for continuity of care with relevant stakeholders including government and non-government care agencies and general practitioners. Services provided include: case management, therapeutic interventions, consultation and liaison with local hospitals, case conferencing and referral to other services and information and community education. Medical outreach clinics for Adult, Older Persons and Child and Youth are provided on site by medical staff from Toowoomba and West Moreton Mental Health teams.

<u>Cherbourg</u> is an indigenous community in the South Burnett area. The Division funds 3 positions to provide services to this community, one is an indigenous position and the other two are Mental Health clinical positions. Medical outreach to this team and clinical governance is provided by IMHS (outside the scope of this survey but mentioned for contextual reasons).

Across Toowoomba and Darling Downs (MH), Service Wide functions are supported by several teams.

All of these functions are aligned with and linked to District-wide processes and requirements.

#### **West Moreton Sector**

Two services are located within this sector, these are the Park - Centre for Mental Health and West Moreton Intgerated Mental Health.

- **6.** <u>The Park Centre for Mental Health</u>, Treatment, Research and Education is situated in the West Moreton sector of the District. It provides a diverse range of tertiary mental health services to the people of Queensland, particularly to those in the south-east corner of the state. There are 192 inpatient beds spread across clinical programs which include:
  - High Security Clinical Program (61 beds),
  - Medium Secure Clinical Program (34 beds)
  - Extended Treatment and Rehabilitation (51 beds)
  - Dual Diagnosis Clinical Program (31 beds)
  - Barrett Adolescent Unit (15 beds).

#### **Target Population**

• The clinical programs offer tertiary level services to consumers of the Southside, Princess Alexandra Hospital, QEII Hospital and West Moreton Sector of DDWMHSD.

#### Statewide Role:

The Adolescent (Rehabilitation) Clinical Program High Security Clinical Program

Situated on the campus at the Park, there are further Statewide and District treatment, education and research facilities which include:

#### **West Moreton Integrated Mental Health Services**

7. The Integrated Mental Health Services (IMHS) are delivered from sites in Goodna, the Community Health Plaza in Ipswich, and Ipswich Hospital Campus. a clinic for child. Outreach services are delivered to the rural communities of Laidley, Boonah and Esk and Cherbourg. The role is to provide care either in an acute or community setting. IMHS is located at three settings

- Goodna (Community Health)
- Ipswich (Community Health Plaza)
- Ipswich Hospital Campus.

#### The services IMHS provide are:

- a) Mental Health Unit (Adult) 28 beds, including 4 HDU beds
- b) Older Persons Mental Health Unit 9 beds acute, and 7 beds extended care
- c) Crisis Assessment and Treatment Team & Consultation Liaison (CATT/CL)
- d) Continuing Care Team (CCT's) (Ipswich and Goodna)
- e) Aged Care Mental Health Service (ACMHS)
- f) Child and Youth Mental Health Service (CYMHS)
- g) G.P. Clinics (Mental Health Nurses)
- h) Evolve Therapeutic Services
- Service wide Support functions:
  - Dual Diagnosis Coordinator,
  - o District Forensic Liaison Coordinators
  - o Quality Facilitator
  - Clopine Coordinator,
  - o Service Integration Coordinator
  - Multicultural Mental Health Coordinator
  - o Consumer Consultant
  - Mental Health Intervention Coordinator
  - Mental Health Information Manager
  - Mental Health Act Coordinator.

IMHS services are deliverd by a multidisciplinary range of health workers from the areas of medical, nursing, social work, psychology, speech pathology, occupational therapy, psychiatry and administrative personnel.

Services provide several options including intake, assessment, case management, psycho education and specific evidence based therapeutic interventions to clients in the community and inpatient settings. A shared care model (General Practitioner, Private psychiatrist, other service providers) is preferred and implemented wherever possible. The service also consults, liaises and conducts assessments for clients admitted to district hospitals.

## Changes or Issues over the Last Two Years:

The process of health reforms has resulted in the reallocation of Distirct boundaries in Queensland. Locally the Darling Downs WEst Moreton HSD has dissolved to create two Health Service Districts (HSD), West Moreton HSD and Darling Downs HDS on 1 July 2011. This change has occurred within three years of an earlier restructure of Queenland's Health in August 2008 wherein the Darling Downs West Moreton HSD (DDWMHSD) was created. The process is described more detail in the previous section: Role and Function. Importantly, for the purposes of accreditation, the Division of Mental Health will retain the current governance structures that align with DDWMHSD. Within that structure, the Division of Mental Health was established to deliver a comprehensive range of acute inpatient, community and extended inpatient services across the lifespan.

The objectives of the Division are to:

- develop a Division structure within the new DD WMHSD that provides a framework for resource allocation, accountability and service alignment that is consistent with and incorporates other Divisions within the District.
- ensure communication and consultation with staff, unions, key stakeholders and partners is in accordance with Queensland Health's change management guidelines
- define the organisational structure and governance framework in the Division of Mental Health structure to improve:
  - Clinical governance in the division;
  - o Corporate governance in the division;
  - Staff morale and organizational culture;
  - o Patient safety and satisfaction; and
  - Consumer and carer participation at all levels.

Outcomes that have been pursued are a Division structure which supports the delivery of:

- Improved strategic and operational effectiveness and efficiency for the health service district;
- A Mental Health Service that is responsive to consumer needs, and emerging practice;
- High level consumer outcomes whilst creating flexible opportunities for care enhancement, innovation and recovery focussed care.
- Consistent standards of care which addresses the geographical challenges of the Division;
- Mental Health Services with a District wide focus approach (not sectorised);
- Mental Health Services where there has been localised differences of service delivery.

In addition to the overarching changes, major organisational change is underway at The Park-Centre for Mental Health and commencing for Baillie Henderson Hospital in line with the Queensland Plan for Mental Health Services 2007 – 2017. This has involved a complex change management process that has included the management of significant infrastructure projects.

Within the West Moreton Sector this includes:

- A new 9 Bed Assessment Unit within the High Secure Inpatient Service (opening late 2011),
- A new 18 Bed Community Care Unit at Gailles (planned for opening late 2012)
- Upgrade of facilities to accommodate a 20 bed Forensic Extended Treatment Unit.

 Relocation of the Adolescent Extended Treatment Unit (Barrett Adolescent Unit) to the Redlands Hospital campus which has been delayed on environmental grounds.

 Relocation of consumers from existing Extended Treatment and Rehabilitation and Dual Diagnosis program areas at The Park, to Community Care Units planned at Logan, Bayside and Princess Alexandra in the Metro South Health Service District.

Within the Darling Downs Sector this includes:

- A new 8 bed Acute Adolescent Inpatient Unit, with 14 place day program (opening late 2011)
- A new 20 Bed Community Care Unit in Toowoomba (2012 2017)
- A new 16 bed Older Persons Extended Treatment Unit in Toowoomba (2012 -2017) consumers from existing services at Baillie Henderson Hospital will be relocated to this facility.
- Relocation of consumers from existing Extended Treatment and Rehabilitation and Dual Diagnosis program areas at Baillie Henderson Hospital, to Community Care Units planned at Central and Fraser Coast Health Service Districts.
- In addition Baillie Henderson Hospital continues to provides services within two units to
  consumers with a single diagnosis intellectual disability, ongoing collaborative planning with
  Disability Services is occurring in relation to the future service model and location of services for
  this client group.

The diverse geography of the District poses challenges to consumer care and staff support. Videoconferencing throughout the Distirct has allowed for effective communication. Most importantly for example, at Dalby fortnightly videoconference clinics in Northern Downs Mental Health Service with visiting Consultant Psychiatrist have been delivered.

A major challenge to all health services and especially mental health services has been the Natural Disaster and other flood events occuring late in 2010 and in January 2011. This required a disaster response that included importing staff form NSW who complemented staff from the Division to provide services to vicitims of the disaster. The disaster also affected staff of the Division. It would be fair to say that comfort and support offered to staff at this time demonstrated the important caring links between staff and corporately. Notwithstanding, the impact is ongoing as the Division prepares for a sustained recovery effort with the initiation of a team of clinicians who will deliver therapeutic services over the next two years. It is anticipated that this will attract staff from the MHS and it is feared that recruitment of these staff may deplete existing teams.

Security of inpatients is an ongoing and contentious issue at the Park that requires careful attention by the Executive. In addition, the management of the Budget is an issue that has been at the forefront.

Although there will be a separation into two Divisions in line with the organisation changes brought on by health reforms, it is the intention of the Executive that the objectives and proposed outcomes will be sustained and that realationships formed during the time of the current Division will result in opportunities to benchmaark the two emerging Divisions. It has been a sign of the resilience of the Division and its management that the benefits of aiming for consistency of care with responsiveness to local settings, although challenging is a desirable goal.

## **Demographics:**

The Health Service District services a population of around 480,000 people. The District's demographics are diverse and include metropolitan, large rural town and small rural community settings. The Division of Mental Health represents approximately 40% of the State's mental health services, making it the largest integrated service in the State.

The West Moreton District is acknowledged (ABS, accessed 7/7/2011) as the fastest growing region in Queensland. Within this district, Ipswich and Somerset are ther areas of most rapid growth at 3.5 and 4.9% p.a. Across the District, the population predominantly Australian born (362168) followed by those born in the UK (15397), New Zealand (9087), South Africa (1719). Other groups of over 1,000 people include those from the Phillipines, Vietnam, Germany and the Netherlands although many people (26369) did not disclose their country of origin. People who identify as indigenous comprise 10,520 - our third largest population group. Of these, 5553 people are under the age of 19 (presumably they are also Australian Born). Indigenous and migrant groups have enriched the culture of the District over time. Some have arrived in Australia from areas that have a history of war in the more distant past and more recently from areas of conflict, others seek the lifestyle that the District has to offer.

Within the West Moreton District, there are a number of large correctional facilities and there has been a history of institutions for those who are intellectually disabled and those who have had serious mental illnesses. The process of deinstitutionalisation has had an impact on the community and its perceptions of people with these conditions. In the Rural areas, the agricultural economy had been drought affected and, recently flood affected causing financial, social and emotional hardships. The effects of natural disaster in Southern Queensland have been well publicised and the long term impact is yet to be fully understood.

#### 1. Inspection or Review Undertaken:

Qld Fire & Rescue Service Maintenance Inspection, Ipswich Health Plaza
