As you are aware there is currently a process being undertaken for allocation of a limited number of HASP packages across the state for 2014-15. In order to allow [REDACTED] equal opportunity to gain access to a HASP package for 2014-2015, without disadvantaging either HHS, it has been agreed to allow one additional nomination to the statewide pool. If you are both agreeable, please progress a joint nomination from West Moreton and Metro North HHS for inclusion in the selection process for 2014-15 (see attached for required documentation and timeframes).

This joint nomination will require the nomination paperwork to be developed collaboratively and approved by required delegate in each HHS. This nomination does not need to be ranked against other nominations from either HHS.

Please note that the inclusion in the process is not a guarantee of a HASP package but allows this

consumer to be given an equal opportunity for funding and does not disadvantage either Metro North or West Moreton HHS by reducing their nominations.
